



Merit-Based Financial Award Application

CIMBA Italy Programs – Summer Graduate

CIMBA offers a limited number of merit-based awards to program participants. To be eligible for a merit-based award, a student must 1) have applied and been accepted to the CIMBA Program, 2) have a cumulative GPA of 3.3 or higher, and 3) submit a letter of recommendation from a professor or teaching assistant explaining why you are a good candidate for a merit-based CIMBA award. Please note that if you are a UI student who is also applying for the UI Office for Study Abroad Merit-Based Award, you may use one of the same letters of recommendation submitted for it but please request that the referee submit a copy of the letter directly to the CIMBA Office. If both copies are sent to the Office for Study Abroad, there is no guarantee that it will be forwarded on to the CIMBA Office.

1. Describe how you expect CIMBA and your time abroad to contribute to your academic and personal goals.
2. Explain why you believe you are a good candidate for a merit-based CIMBA award. This statement should deal with your personal history, family background, intellectual interests, educational achievements, cultural opportunities to which you have been exposed, and the ways in which these experiences have affected you. Include information about awards or recognition you have received, participation in extracurricular activities, and special interests and abilities.
