The Spring 2011 program dates are January 17 through April 15, 2011. You will live in a residence hall on a full-service campus in Paderno del Grappa, Italy (about an hour from Venice). Two, one-week travel breaks, two extended weekends, and most weekends are reserved for independent travel. Students may select up to 18 units of coursework. The courses, which are taught in English, are international in flavor and designed to satisfy core or elective requirements so that students stay on track toward graduation. **All courses are subject to change, but the italicized courses are the most tentative.**

Cost

The projected program cost for spring 2011 is \$14,895 which covers many expenses not included by most study abroad programs. Included are: tuition for up to 18 credits, a double occupancy room in on-campus residence halls, meal package (3 meals daily when class is in session), rental fee for books and materials, buses to and from train stations for travel breaks, housekeeping, linen and towel fee, 9 loads of laundry, and 3 gourmet dinner excursions for authentic multi-course Italian meals. Costs are based on projected Euro exchange rates and are subject to change. Airfare, travel within Europe, and personal expenses are not included in the program cost. Some universities also charge a study abroad fee so check with your home university regarding this.

Financial Awards & Financial Aid

CIMBA will provide a breakdown of all program expenses and estimated personal expenses for use by your financial aid office upon request.

General Requirements

- At least 18 years old.
- Good academic standing at home institution.
- GPA of 2.5 or higher.
- Sophomore status and/or required prerequisites.
- Must enroll in at least 12 credits during program.
- Valid passport/documentation from country of citizenship.
